- iii) Applicant shall be responsible for any litigation, it any, regarding land in any court of law.
- iv) Applicant shall not start any development work until building plans are approved by the Competent Authority.
- v) Through revenue rastas passing through the site shall be kept unobstructed.
- vi) Application shall obtain NGC from PPCB under the Water (Prevention and Control of Pollution) Act1974, Municipal Solid waste Management and Handling Rules 2000 or any other relevant Act before starting and development at the site.
- vii) Building Plans of the entire project shall be got approved from the Competent Authority.

- viii) Applicant shall not make any construction under HT/L.T. electric lines passing through the site or shall get these lines shifted by applying to the concerned Authority
- ix) This permission will not provide any immunity from any other Act/Rules/Regulations applicable to the land in question.
- x) Promoter shall obtain NOC from the Forest Department, if required, before starting development at the site.
- xi) Applicant shall make provision of rain water harvesting within the project area at its own cost.
- xii) Applicant shall make its own suitable provision for drinking water supply and disposal of sewage & solid waste.
