- That the management shall discharge the statutory obligations relating to provident fund ,pension, gratuity etc. in respect of all employees.
- 9. That the management will make adequate funds available for providing satisfactory facilities and for proper programmed implementation.

- 10. That the account of institution will be, properly maintained and audited annually by the audit authorities or a Chartered accountant, and will be open for inspection.
- 11. That the management will be followed be strictly follow all conditions RY and norms prescribed by NCTE from tome to time, conduct the shwani programme in all earnestness and submit itself to inspection by the Saarma NCTE.
